

Dr. Karen Danylchuk 2010 Earle F. Zeigler Lecture



Dr. Karen Danylchuk from the University of Western Ontario, was named as the 21st recipient of the Earle F. Zeigler Award. Dr. Danylchuk is most deserving of this honor, as she has contributed to the field of sport management in multiple facets. This year was no exception to her contributions, as she delivered an intriguing address entitled "Internationalizing Ourselves: Realities, Opportunities, and Challenges".

Karen spoke about the importance of internationalization, its prevalence on university campuses today in response to globalization, and how we as sport management academicians and students may employ an international way of thinking and practice into our teaching, research, and service. Barriers to internationalization were noted, as well as opportunities within our field. Specifically, Dr. Danylchuk highlighted how we as leaders in the field of Sport Management must ensure that we teach, research, and advocate from an international perspective. A snapshot of our progress within NASSM and the field in general was provided along with suggestions for improvement.

What Do We Do Next? Post Conference Remarks from Our President – Dr. James Zhang

I was very pleased to see many of you at the 2010 NASSM conference held in Tampa, Florida. Professor Ross Bartow and his colleagues at the University of Tampa provided us with such a wonderful conference! Karen, Alison, Jim, their students, and the rest of the Western crew are already working hard in preparation for the conference. Although it is 10 months away, I encourage you to make plans to attend the 2011 NASSM Conference. With the economic downturn and the reduction of many travel budgets in higher education institutions, early planning for academic conferences is becoming increasingly important for all of us; particularly, since our annual conference is held at the end of the academic/fiscal year (i.e., May or June). We should all make sure that enough funds are set aside to attend the most important Conference of The Year in our discipline. Typically, the deadline for general abstract submissions is set at the end of October or beginning of November; abstracts for the teaching fair are due in mid-February; and papers for student research competition are due right after the New Year. I encourage you to keep these critical dates in mind when making plans.

Dr. Diana Gray *2010 Distinguished Service Award*

Dr. Dianna P. Gray (University of Northern Colorado) was selected as the recipient of the 2010 Dr. Garth Paton Distinguished Service Award. This Award annually recognizes a member's outstanding service contributions to NASSM. The Award is intended to (a) be one of distinction within NASSM and the award recipient's own academic community, and (b) encourage high standards of service to NASSM and other forms of contribution among NASSM's members.

Consistent with the aims of the Award, Dr. Gray has served NASSM in a variety of capacities. Among her many service engagements; she served a three-year stint as President-Elect, President, and Past-President from 2001-2003. During her presidency, she helped to initiate the electronic submission for conference abstracts, helped to formulate the Society's strategic plan, and developed NASSM's current mark. She also served as co-Chair, with Dr. Jacquelyn Cuneen, of the NASSM Distinguished Sport Management Educator Award in 2007. And, in 2009, she coordinated, also with Dr. Cuneen, the first NASSM Teaching Fair—a successful program that continues today. Finally, she served as a conference reviewer or program chair from 1998-2008.

Clearly, Dr. Gray has made a significant and meaningful contribution to NASSM by giving selflessly of herself. We, as a Society, are thankful for her service and are very pleased to recognize her as the recipient of the 2010 Dr. Garth Paton Distinguished Service Award.

Dr. Bob Baker *2010 Distinguished Educator Award*

Dr. Bob Baker (George Mason University) was announced as the 2010 NASSM Distinguished Educator. Dr. Baker had the following to say about receiving the award:

Looking Ahead:

NASSM 2011, London Ontario.....June 1-4, 2011

Conference Location: The 2011 Conference of the North American Society for Sport Management will be held June 1-4 on the campus of The University of Western Ontario in London, Ontario, Canada. London, referred to as "The Forest City", is situated approximately halfway between Detroit-Windsor and Toronto. The University of Western Ontario, with an enrolment of 32,000 students, is one of Canada's leading research-intensive universities offering over 200 programs in 12 faculties. Sport Management is housed within the School of Kinesiology in the Faculty of Health Sciences.

Beyond the university, London has many cultural, sporting, and outdoor activities for conference members to enjoy. Stratford, one of the largest theatre districts in Ontario, is a short 45 minute drive down Hwy. 401, while many other theatre and art destinations are housed right in the core of downtown London. From Richmond Row where you can enjoy a little shopping action and fusion cuisine to the John Labatt Centre to golfing and bike trails, you might find it worthwhile to even extend your stay to take in the sites of this Ontario NASSM conference location.

Academic Sessions and Accommodation: All academic sessions will be held in the Faculty of Health Sciences Building conveniently located a few minutes by foot from the conference accommodation site of London Hall. The Station Park Inn on the edge of the downtown core 10 min. from campus is the alternate host accommodation for those attendees who do not wish to stay on campus. There will also be two smaller accommodation venues available that are located on the periphery of the campus—Ivey Spencer Leadership Centre and Windermere Manor.

Getting to London: London's International Airport, which is approximately 15 minutes from campus, operates daily flights direct from Chicago via United Airlines; Detroit via Delta Airlines; Orlando, Vancouver, Calgary, and Winnipeg via WestJet; and Toronto and other Canadian cities via Air Canada. Access by car may be through the borders of Detroit-Windsor (two-hour drive to London), Port Huron-Sarnia (one-hour drive to London), and the three Niagara crossings of Buffalo-Fort Erie, Niagara Falls, NY-Niagara Falls, ON, and Lewiston-Queenston (two and a half hours to London).

First Sport Management Programs Accredited *Slippery Rock and Saint Leo Lead the Way....*

The Board of Commissioners (BOC) of the Commission on Sport Management Accreditation (COSMA) made its first accreditation decisions at its June 2-3, 2010, meeting. Two member institutions, Slippery Rock University and Saint Leo University, conducted site visits in the Fall of 2009 and Spring 2010 as a final step toward accreditation. Each institution submitted a comprehensive Self-Study that addressed the eight (8) Principles outlined in COSMA's accreditation manual.

The Slippery Rock University (SRU) Sport Management Department, located in Slippery Rock, PA, is chaired by Dr. Robin Ammon. The accreditation effort was coordinated by Dr. Robertha Abney, a newly-elected member of the COSMA BOC. The Department of Sport Management is an academic unit within the College of Education, and SRU's Sport Management B.S. degree provides practical undergraduate education with a focus on student development in the field of sport business. As one of the oldest academic Sport Management programs in the country, they are committed to maintaining their reputation as one of the sport industry's premier partners in sport management education.

The Sport Business program at Saint Leo University is chaired by Phil Hatlem, and the accreditation effort was coordinated by Dr. Eric Schwarz. Both Saint Leo's Sport Business B.A. degree and online MBA in Sport Business are accredited. The Sport Business B.A. provides a foundation of study in business applied to the sport industry, its products, and its services. The online MBA Sport Business degree is designed to prepare working professionals for a successful career with professional sport franchises, facilities, sporting goods retailers, athletic departments, and industry segments constantly calling for sport business specialists.

Inaugural Meeting: *African Sport Management Association (ASMA)*

Nairobi Kenya — As a relatively new academic discipline originating in American colleges, sport management has spread internationally during the past two decades. The newly-formed African Sport Management Association (ASMA) is the brainchild of delegates from countries throughout Africa who met at Kenyatta University June 6-8, 2010. The International Society for Comparative Physical Education and Sports conference organizer, Dr. Peter Wanderi, declared that "... now is the time for Africa to join the rest of the world in starting its own association for the advancement of the study of sport."

The newly elected ASMA President, Dr. Kihumbu Thairu, Vice Chancellor of The Presbyterian University of East Africa explained that the organization was created by the "... energy, enthusiasm, and strategic thinking of professionals in Africa who see the value of a strong sport management curriculum that promotes the scientific study of sport for the multiple roles of service it can offer to our countries overall quality of life."

The assembly also agreed to train professional sport managers at all levels within Africa to improve and strengthen sport management in all African countries. The group will attempt to develop linkages with other more established Universities, host a ASMA conference in Nigeria, fall 2011, and begin the process of developing sport management curriculum to meet the needs and interest of Africans to improve their quality of life and promote the training of young college graduates to advance the quality of life of Africans through sport.

Janet Fink: Dr. Fink was recently elected as the President-Elect of NASSM. She is currently an Associate Professor at the University of Connecticut. Prior to arrival at the University of Connecticut, she was an Associate Professor at The Ohio State University and also served as the Section Head in the Department of Sport and Exercise Education, Humanities, Management, and Sciences. Dr. Fink's research interests include diversity issues in sport, sport media and the female athlete, and sport fan behavior. Her professional accomplishments include over 45 authored and co-authored articles that have appeared in numerous refereed publications. In addition, she has presented at several national and international conferences. Dr. Fink has been awarded grants from organizations such as the United States Tennis Association and the Women's Sport Foundation to support her research initiatives. Her service to the profession is significant, as she serves on the Editorial Board for the *Journal of Sport Management* and *Sport Marketing Quarterly*. She has also served as a reviewer for many other scholarly publications during her career. Lastly, Dr. Fink has earned several awards with regard to excellence in research and teaching. She was inducted as a NASSM Research Fellow in 2006 and received The Ohio State University's Award for Distinguished Teaching in 2007.

Laura Misener: Dr. Misener was elected to serve as a Member-at-Large on the Executive Council. She is an assistant professor in the Department of Kinesiology at the University of Windsor. Her research interests include: (a) the social impacts of sporting events with a focus on strategic community development, (b) sport and events as tool for increasing sport participation, and (c) strategic partnerships in physical activity, sport, and health promotion. Dr. Misener has published her work in several refereed, scholarly journals. She has presented her work at conferences conducted by NASSM, the North American Society for the Sociology of Sport (NASSS), and the International Society for Comparative Physical Education and Sport (ISCPES). Dr. Misener has successfully acquired grants from the Social Sciences and Humanities Research Council of Canada (SSHRC) and Canadian Association for the Advancement of Women in Sport in order to support her many research initiatives. Finally, she serves as the University of Windsor's representative on a local physical activity and health promotion initiative, *Southwestern Ontario in motion*.

Laura Cousens: Dr. Cousens was recently elected as a Member-at-Large on the Executive Council. She is currently an Associate Professor in the Department of Sport Management at Brock University. Prior to her tenure at Brock University, Dr. Cousens lectured at the University of British Columbia and at Central Queensland University in Australia. Dr. Cousens' program of research has evolved marketing and sponsorship, change at the organizational and industry levels of analysis, and inter-organizational relationships. More recently, she has investigated networks of community sport providers as well as the economic impact of sport tourism events. Her work has appeared in several refereed journals. Dr. Cousens has secured several grants to support her work. She has been awarded grants from the Sport Participation Research Initiative of the Social Sciences and Humanities Research Council of Canada as well as Sport Canada. Lastly, Dr. Cousens has served as a member of the Editorial Board for the *International Journal of Sport Management and Marketing* and has also served as a co-editor of a special issue focusing on interorganizational relationships for the *International Journal of Sport Management and Marketing*.
